No. 19/4/2002-T(MV).-In supersession of this Department Notification of even No. dated 2nd May' 2002, and in exercise of powers conferred by Section 4 of the Manipur Passengers and Goods Taxation Act' 1977 (Act 1 of 1978) read with Rule 11 of the Manipur Passengers and Goods Taxation Rules, 1979, the Governor of Manipur is pleased to fix lump sum taxes at the rates specified below payable w.e.f. the date of publication of the above Notification in the Official Gazette, in lieu of tax chargeable on Fare and Freight on return basis in respect of various types of Commercial Vehicles against them:-

- * Inter State Stage Carriage (Medium) means a Medium Bus whose gross vehicle weight lies between 7,500 kgs. and 12,000 kgs.
